### Potential Health Effects (Acute and Chronic):

This product has not been tested as a whole to determine health effects. The health effects listed below are associated with the individual ingredients listed in Section 3.

**EYES:** Irritating to the eyes. Causes itching, burning, redness and tearing. May cause corneal injury.

**SKIN:** May cause skin irritation. Prolonged or repeated skin contact with liquid may cause defatting resulting in drying, redness and possible blistering. Skin absorption can transport other toxins into the body.

**INHALATION:** Causes respiratory tract irritation. Vapors may be irritating to eyes, nose, throat, and lungs.
